

The Corporation of the Township of North Kawartha

By-law 2024-0018

Being a by-law of the Corporation of the Township of North Kawartha to amend By-Law 2020-0004 and to repeal By-Law 2014-007.

Whereas under Section 8(1) of the Municipal Act, 2001, S.O. 2001, c.25 provides that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

And Whereas under Section 9 of the Municipal Act, 2001, S.O. 2001, c. 25, provides a municipality has the capacity, rights, powers and privileges of a natural person;

And Whereas the Council of the Corporation of the Township of North Kawartha passed By-Law 2020-0004 on the 14th day of January, 2020 being a by-law to delegate municipal powers and duties and to repeal By-Laws 2007-0122, 2008-0057, 2011-0005 and 2015-0011;

And Whereas the Council of the Corporation of the Township of North Kawartha passed By-Law 2014-007 on the 21st day of January, 2014 being a by-law to adopt a "Public Request for Municipal Service(s)" Policy for the Township of North Kawartha;

And Whereas the Council of the Township of North Kawartha approved the "Use of Municipal Facilities and Resources for a Reduced Rate or Free of Charge" policy by motion on the 19th day of March, 2024 to replace the "Public Request for Municipal Service(s)" policy;

And Further Whereas Council deems it expedient to amend By-Law 2020-0004 to provide authority to the Clerk and Director of Parks and Recreation and Waste as set out in the "Use of Municipal Facilities and Resources for a Reduced Rate or Free of Charge" policy;

Now Therefore the Council of the Corporation of the Township of North Kawartha enacts as follows:

1. That By-Law 2020-0004 be amended to remove the following section:

Matter	Delegate	Delegated Authority; Terms & Reporting Mechanism
Use of North Kawartha Community Centres without charge or at a reduced rate.	Director of Parks & Recreation	Authority to waive fees or reduce charges for use of the Community Centres in accordance with in-effect Policy. A report shall be provided to Council monthly.



And to replace with the section below:

Matter	Delegate	Delegated Authority; Terms & Reporting Mechanism
Use of Municipal Facilities and Resources for a Reduced Rate or Free of Charge Policy	Clerk	Authority to oversee the implementation of the policy, approve applications in a fair and consistent manner, in

		line with the overall goals and objectives of the policy and to make minor amendments to the policy and application forms. At the discretion of the Clerk an annual report may be provided to Council.
Use of Municipal Facilities and Resources for a Reduced Rate or Free of Charge Policy	Director of Parks and Recreation and Waste	Authority to grant free or at a reduced rate usage of any of the three (3) Community Centres or Parks in compliance with the Policy. Free use to include free ice time, fitness memberships or the use of banquet facilities. As requested by the Clerk provide an annual report to Council.

This by-law shall come into effect on the 2nd day of April, 2024.
