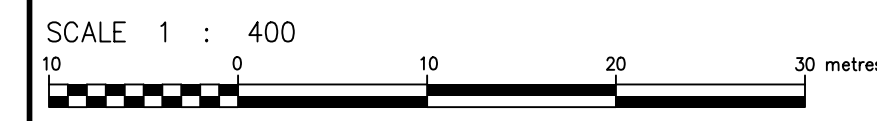


SKETCH TO ILLUSTRATE PROPERTY LINES AND ENCROACHMENTS IN
