Dear Mayor Amyotte and Members of North Kawartha Council,

On behalf of the Jack's Lake Association Board of Directors and our members, we are writing to express our strong opposition to the proposed reclassification of the municipal boat launch at Sharpe's Bay on Jack Lake as surplus property.

We urge Council to reverse this decision. This launch is a critical public access point that serves not only lake residents and businesses but also emergency services, whose ability to respond swiftly to incidents on the lake depends on its continued operation.

This municipal boat launch is the only public access point to Jack Lake within North Kawartha Township and serves as the primary entry point for emergency responders, including fire, police, and paramedics, to reach the southern half of the lake (south of the Narrows).

In situations where every second counts—whether for a fire, a medical emergency, or a water rescue—the loss of this launch would severely impact response times and put lives at risk.

Beyond emergency response, this launch is heavily relied upon by:

- Utility and service providers who require water access to perform essential maintenance.
- Local businesses for seasonal boat and dock deliveries.
- Residents and visitors who depend on this site for safe and equitable lake access.

Furthermore, during periods of low water levels, the Narrows can become unsafe to navigate, cutting off the southern portion of the lake from the only other public access point at the northernmost end of the lake. In such cases, this boat launch becomes the

only viable access for emergency and essential services, as well as landowners with water access only properties.

Given these critical functions, we strongly believe that this is not surplus land but rather an essential community asset that should remain municipally owned and maintained. We urge Council to immediately reconsider and reverse this classification to ensure that public access and emergency response capabilities are not compromised.

However, if Council is unwilling to commit to reversing the decision at this time, we strongly request that any final decision be deferred until at least July 2025. This deferment would allow residents, taxpayers and stakeholders the opportunity to conduct further research, present their concerns in person, and explore alternative solutions to maintain public access to the southern basin of Jack Lake.

I just watched the Council meeting today in connection with the Boat Launch FR52. I am very concerned there is no Township legal counsel present at the meeting correcting the Mayor's inaccurate representations about legal and prescriptive rights under Ontario law. Further I have electronically attended the multiple meetings on the subject matter since December 3, 2024 with no opportunity provided to allow North Kawartha Township constituents attending to speak. I wish to convey my input in the matter further to my original submission below when I first heard about it on December 2, 2024.

As noted in the letter of November 19, 2024 by legal counsel representing the Township, the conveyance of the subject lands to the Township was in satisfaction of parkland dedication. My understanding and that of numerous neighbours is that the subject property was deeded by Peterborough Lumber to the Township for use as a boat launch by the lot owners purchasing lots from Peterborough Lumber. I spoke with the former Peterborough Lumber CFO who confirmed the same. Again, I fail to understand how the Township can ignore the original intent of the land transfer and the wishes of the surrounding lot owners that were the intended beneficiaries as evidenced by its long standing historical use.

Furthermore, why is the subject land now considered as surplus when it was the Township that agreed to the conveyance in 1978. Nothing has changed. The surrounding private properties were always there. The Township as with the surrounding lot owners have had unencumbered access to the boat launch for no monetary consideration for well in excess of 20 years. Legal counsel representing the Township will appreciate the significance of the forgoing.

I'm writing to you today to express my concerns about the Boat launch potentially being sold. One issue is with the fact that all the cottagers would have to access the marinas early spring and late fall to take our boats in and out of the water. That is a high volume of watercraft especially when people own more than one watercraft. Not to mention that a number of outside fishermen utilize the lake for their enjoyment as well. Vehicles with boat trailers line either side of the road leading into the water any given day. I'm sure the trailer park people would not want all that volume of people.

The main issue I have is with regards to safety. There was a fire in the lower part of the lake, emergency services were able to get their sooner as they were able to drop their boats into the water at the boat launch. It takes approximately 15-20 mins depending on boat traffic to get from the marina, through the narrows to the lower part of Jack lake. Those minutes are valuable life saving minutes in a real emergency.

Is there any thought being given to creating another public boat launch that would service the lower end of the lake south of the narrows? Sharp's Bay is the largest part of the lake. Many cottagers utilize the boat launch on fireroute 52A. Why is the bylaw committee wanting to re-zone that area and put it up for sale? It has been in use since the 70s. Objection to Proposed Sale of Boat Launch on FR52A

Dear Mayor Amyotte and Councillors,

I am registering my strong opposition to your vote to declare the boat launch property on FR52A as "surplus" with a recommendation to sell. As I'm sure you're aware, there is nothing surplus about this property, and it is, in fact, essential.

Through this letter, I am requesting that Council not proceed with selling the boat launch, which is important for the use and enjoyment of our properties. More important, it is critical for facilitating emergency services to other island or non-road properties on a large section of lake within North Kawartha (NK) and Havelock Belmont Methuen (HBM).

This launch has been a valuable, shared community resource for more than 40 years and used by many on the lake – whether they are in NK or HBM. It is a critical access point for emergency services, fire, OPP, Hydro One, Bell Canada, etc. It is valued by many in the community as a place to launch pleasure boats (NOT industrial barges) and my family has been doing so since the 1970s. And should the property sell, what is to stop a new owner from erecting fences/gates or other barriers, which block any access by first responders?

It is also surprising that NK township didn't bother to enforce its own bylaw banning commercial use when there was an onslaught of industrial barging, noise and off-gassing throughout the summer of 2024 -- despite numerous requests and complaints.

Then, without any consultation with or notification to residents, you essentially blindside the community and declare the property "surplus."

I believe this is not acting in good faith. In bylaw 2007-0106, it requires that the municipality, when carrying out the sale of its land, act in good faith. In addition, this recent decision at Council is a betrayal of an arrangement that has been in place for nearly 50 years and which benefits everyone on the lake – no matter where they are located.

Issue of "Trespassing"

In addition, I noticed that in the *Peterborough Examiner* that Mayor Amyotte has rationalized the decision to sell the property by alleging that the launching cannot take place without trespassing on private property. My family cottage is on FR52A and I do not accept that I am trespassing by using this launch facility. It is important to understand the

implication of private roads that serve all the cottagers on Jack and other lakes in the township.

I can assure you there has never been even one accusation or legal action regarding trespassing regarding this property over more than four decades.

Any travel on private roads when accessing other properties does not equate to <u>trespassing</u>. If that were true then we would have to trespass to access our own properties. In fact, any real estate lawyer would identify this as a title defect and sales transactions over many years would not have closed.

Cottagers should have confidence in the many lawyers who gave their clients advice that they had the legal right to travel on private roads such as FR52 and FR52A.

I have reviewed the video of the last Council meeting and fully support the opinion of my neighbour Max Steinman that any moves to sell this property will lead to continued pushback and more contention going forward.

We need harmony and we need the respect of NK Council on this issue. I am joining my neighbours and others on the lake in asking all members of Council to NOT vote in favour of selling this valuable community resource and ensuring it remains as a valuable lake resource for years to come.

Councillors – My husband and I own a property on Jack's Lake in Sharpe's Bay and rely on the municipal boat launch at Fire Route 52A (Four Corners) for maintenance and servicing of our property.

Removing this access point is not in the best interest of residents/cottagers on Jack's Lake for the following reasons:

- Emergency services (fire, police, paramedics) to respond to incidents on the lake.
- Residents and visitors who rely on it for safe and equitable lake access.
- Local businesses and service providers who use it for boat and dock deliveries.
- ✓ Utility and maintenance crews who require water access for essential work.

Good afternoon Connie,

I just watched the Council meeting today in connection with the Boat Launch FR52. I am very concerned there is no Township legal counsel present at the meeting correcting the Mayor's inaccurate representations about legal and prescriptive rights under Ontario law. Further I have electronically attended the multiple meetings on the subject matter since December 3, 2024 with no opportunity provided to allow North Kawartha Township constituents attending to speak. I wish to convey my input in the matter further to my original submission below when I first heard about it on December 2, 2024.

As noted in the letter of November 19, 2024 by legal counsel representing the Township, the conveyance of the subject lands to the Township was in satisfaction of parkland dedication. My understanding and that of numerous neighbours is that the subject property was deeded by Peterborough Lumber to the Township for use as a boat launch by the lot owners purchasing lots from Peterborough Lumber. I spoke with the former Peterborough Lumber CFO who confirmed the same. Again, I fail to understand how the Township can ignore the original intent of the land transfer and the wishes of the surrounding lot owners that were the intended beneficiaries as evidenced by its long standing historical use.

Furthermore, why is the subject land now considered as surplus when it was the Township that agreed to the conveyance in 1978. Nothing has changed. The surrounding private properties were always there. The Township as with the surrounding lot owners have had unencumbered access to the boat launch for no monetary consideration for well in excess of 20 years. Legal counsel representing the Township will appreciate the significance of the forgoing.

I trust you will share this with Township Council. Kindly acknowledge receipt of this email. Thank you.

I have reviewed a Public Notice indicating that the Township of North Kawartha has declared those Lands being part lot 6 & 7 Concession 15 (former Township of Burleigh) Township of North Kawartha, being part 40 on Plan 45R-363, more commonly known as the Jack Lake Community Boat Launch on Fire Route 52A, to be surplus to the needs of the Township, and that it intends to sell the Lands by public tender. I understand that Council will consider passing the bylaw at Council meeting Mar 18th. I am forwarding this email to you now to voice my objection to declaring this property surplus and any future sale.

I submit that the long established and continuously utilized municipally owned boat launch serving approximately 90 cottager owners on the south shore of Sharpes Bay is not surplus. The original subdivision developer, Peterborough Lumber Company (PL) created a boat launch for their cottager buyer clients to provide a convenient boat launching facility since no other such facility was available in the South basin of Jack Lake. In 1978, PL transferred this property to the Township and for about 40 years the community of cottage owners in the area have... without any expenditure to the township... utilized this facility for launching and removing watercraft from Jack Lake. In addition, during the winter season this property has facilitated access to the lake enabling connections to trail systems and... also facilitating ice fishing huts arriving and departing the lake. More importantly for consideration of the Township, the established lake access has also served the emergency services operations including fire, rescue and ambulance to effectively respond to the vital needs of the south half of Jack Lake in both North Kawartha and Havelock Belmont Methuen Townships and has assisted utilities such as Telephone and Hydro to respond to emergency service requirements in this area.

I respectfully submit that these Lands are not surplus to the needs of the Township or its constituents and I wish to record my formal objection to declaring this property as surplus and any future sale.
