He explained the reasons for anxiety around the issue of declaring the lands surplus and selling. He requested that Council to keep in mind that folks enjoy using the boat launch for recreational purposes and asked that Council vote against selling the lands and work with the community to write a site-specific zoning by-law to ensure folks could still launch boats but have protection against commercial barging use.
